DOG LICENSES

It is required by law for your dog, if over the age of four months and residing in the congested areas of Washoe
 County, to be licensed with Washoe County Regional Animal Services? Failure to license your dog may result in a \$100 to \$400 fine.

Annual license fee:

- Unaltered dog: \$20.00
- Altered dog: \$8.00 (spayed or neutered)
- Senior citizen with an unaltered dog: \$8.00 (60 years old or older)
- Washoe County Residents can now easily license their dog online at <u>washoe.docupet.com</u>

BENEFITS OF LICENSING

Not only does a dog license provide proof of ownership, it also helps get your dog reunited with you if they ever become lost. Every year hundreds of dogs are reunited with their owners because they were licensed. License fees also help fund local animal welfare initiatives in the community.



MICROCHIPS

- •Washoe County Regional Animal Services believes that microchipping is your pet's best chance of being returned home should it ever become lost or stolen
- Microchipped pets can be scanned in the field and returned to their owners without ever having to be brought into the shelter.
- •All pets are scanned in the field for microchips before being brought into the shelter. Our Officers make every attempt to reunite pets with their owners.
- All Washoe County residents are able to get their pets microchipped free of charge! Mon-Fri 8am-5pm and Sat 9am-3pm. No appointment needed!



HOW MANY PETS PER RESIDENCE

- Dogs: 5 adult dogs over the age of 4 months
- Cats: 7 adult cats over the age of 4 months
- A Variance Permit is required to have more than 5 adult dogs over 4 months of age or 7 adult cats over 4 months of age.





LIVESTOCK AND POULRTY

- Poultry: Chickens may be kept on properties larger than .28 acre
- Livestock:
 - .5-acre: 2 livestock units (2 goats, sheep, pigs, cattle, horses or a combination of any 2)
 - .75- acre: unlimited livestock

WCC 55.125 - KEEP OF NOISY ANIMALS

- It is unlawful for any person to keep, harbor or own any animal which by making loud and frequent noises causes annoyance to the neighborhood or to any persons in the vicinity.
- While barking dogs are the majority of complaints received, this ordinance is not limited to dogs. Crowing roosters and other animals can cause an annoyance to the neighborhood. Therefore, when reporting a noise complaint, please be specific about the description of the animal causing the nuisance



AT LARGE WCC 55.460



- 55.460 Unlawful for domestic animals, except cats, to be at large in congested areas; damage by animals; capture and impoundment by individuals.
 - 1. It is unlawful for any domestic animal, except a cat, to be at large within the congested areas.
 - 2. It is unlawful for any domestic animal to endanger property, public safety or any other animal.
 - 3. A violation of subsection 1 or 2 is committed by the owner or person having custody, control or possession of the animal.
 - 4. A member of regional animal services' staff or any other person may take up and impound at the animal services center: (a) Any domestic animal, except a cat, which is found at large within a congested area; (b) Any domestic animal which is trespassing on that person s property; and (c) Any domestic animal, which is endangering property, public safety or any other animal
