 - **B.** Special Use Permit Case No. SB10-013 (Mt. Rose Estates Phase 3A Grading) Review and recommendations on the request to construct earthen berms up to 9.5 feet above existing grade on previously graded lots within the Mt. Rose Estates subdivision as authorized in Section 110.810 of the Washoe County Development Code. The project site is located north of Mt. Rose Highway and east of Callahan Road on Paris Court. The 7 parcels totaling ±9.65-acres are designated High Density Rural (HDR) in the Southwest Truckee Meadows Area Plan, and are situated in a portion of Section 35, T18N, R19E, MDM, Washoe County, Nevada.

The property is located in the Southwest Truckee Meadows Citizen Advisory Board boundary and Washoe County Commission District No. 2. (APNs: 150-492-01, 150-492-02, 150-492-03, 150-492-04, 150-492-05, 150-492-06 & 150-492-07). Staff Representative: Trevor Lloyd, 775.328.3620. This application is scheduled to be heard by the Board of Adjustment on April 7, 2011.
