Minutes of the regular meeting of the South Truckee Meadows/Washoe Valley Citizen Advisory Board held August 1, 2019 6:00 p.m. the South Valleys Library at 15650A Wedge Parkway, Reno, Nevada.

1. *CALL TO ORDER/ DETERMINATION OF QUORUM - Meeting was called to order at by Patricia Phillips at 6:05 p.m.

Member Present: Kimberly Rossiter, Shaun O'Harra, Patricia Phillips. A quorum was determined. **Absent:** Tom Burkhart, Jim Rummings (resigned), Bob Vaught (Resigned last year).

2. *PLEDGE OF ALLEGIANCE - the Pledge of Allegiance was recited.

3. *GENERAL PUBLIC COMMENT AND DISCUSSION THEREOF-

Karen Nicholas asked how many time can an application be withdrawn. She said she would like to know if it is withdrawn. She asked how long is it postponed, and what changes have been made. She asked if the County requested changes. Julee Olander, Washoe County Planner, answer her questions. Karen asked if there is another way to voice our opinion. Patricia Phillips advised her of the options on how to submit her comments. Karen asked if the application can side-step this CAB. Julee explained the process of being on the CAB agenda and being heard by the Board of Adjustments and Planning Commission.

Coleen Morrisette spoke about item 6B. She asked if there are penalties for those who abuse the system and withdraw the application last minute. Julee Olander said there are no rules regarding how many times they can withdraw the application. Coleen said the needs of the many should out-weigh the needs and greed of one developer. It goes against the South Valley plans. It impacts the community and views. Please listen and consider the community.

- **6.A.** Master Plan Amendment Case Number WMPA19-0004 and Regulatory Zone Amendment WRZA19-0003 (Bennington Court) Request for community feedback, discussion and possible action to forward community and Citizen Advisory Board comments to Washoe County staff on a request (1) To adopt an amendment to the Forest Area Plan, a component of the Washoe County Master Plan, to approve a Master Plan Amendment from the Open Space (OS) to Suburban Residential (SR) master plan designation on five parcels of land, totaling approximately 8.32 acres; and (2) Subject to final approval of the associated Master Plan Amendment, to recommend adoption of an amendment to the Forest Regulatory Zone Map, to approve a Regulatory Zone Amendment from the Open Space (OS) regulatory zone to Low Density Suburban (LDS) regulatory zone on five parcels of land, totaling approximately 8.32 acres.
