Minutes of the South Truckee Meadows/Washoe Valley Citizens Advisory Board meeting held via zoom on January 7, 2021, 6 p.m.

1. *CALL TO ORDER/ PLEDGE OF ALLEGIANCE – Tom Burkhart called the meeting to order at 6:00 P.M.

2. *ROLL CALL/DETERMINATION OF A QUORUM – Dave Snelgrove, Tom Burkhart, Shaun O'Harra, Kimberly Rossiter. A quorum was determined. Tom Burkhart noted Marge Frandsen is no longer on the CAB.

3. *PUBLIC COMMENT -

Jeff Church introduced himself. He said he is a newly elected Trustee for Washoe County School District. He said looks forward to serving and is enthusiastic about improving quality of education. He hopes to reach out to Spanish speaking community. He said he is retired Air Force and Reno Police.

With no further requests for public comment, Chair Burkhart closed the public comment period.

5. APPROVAL OF THE MINUTES FOR THE MEETING OF NOVEMBER 5, 2020 AND THE MEETING OF DECEMBER 3, 2020— Dave Snelgrove noted he recused himself from the entire December meeting as he was the presenter. Tom Burkhart moved to approve the minutes as corrected. Dave Snelgrove seconded the motion to approve the minutes. The motion carried unanimously.

6.A. Special Use Permit Case Number WSUP20-0023 (Burns Family Grading) – For possible action, hearing, and discussion to approve a special use permit to allow Major Grading, including previous unpermitted grading and earthwork totaling approximately 1,500 cubic yards of excavation, and disturbance of a total area of approximately 187,308 square feet (approximately 4.3 acres). Grading of more than one acre on a parcel that is less than six acres in size is Major Grading in accordance with the Washoe County Development Code at 110.438.35(a)(1)(i)(A).

Derek Wilson, Rubicon Design Group, Applicant Representative, provided a PowerPoint slideshow.

Derek Wilson stated a had realtor told the landowner that it would be better to sell the property if they removed the vegetation. Tom Burkhart asked why did the owner bother and let the new landowner figure it out.

Roger Pelham, Washoe County Planner, said unpermitted grading is not his favorite type of project. He said this is relatively simple project to rectify because they didn't change the topography. The site is relatively flat opposed to a steep grade. This is primarily a permit to restore the property because it does constitute major grading. There is a berm

of the stripped vegetation and topsoil that will can be spread over the disturbed area. As grading goes, this is straight forward.

Shaun O'Harra asked what if it doesn't get approved. Mr. Snelgrove said there has been examples of that and it's not fun. Roger Pelham said it would be a convoluted process that involves code enforcement and the applicant would have to appeal to Board of County Commissioners and there would be steps imposed for remediation.

Dave Snelgrove said he hopes it gets approved because the alternative is complicated. He said he hopes the Board of Adjustment approves this as it's a fix.

MOTION: Dave Snelgrove moved to approve Special Use Permit Case Number WSUP20-0023 (Burns Family Grading). Shaun O'Harra seconded the motion. The motion carried unanimously.
