Minutes of the regular meeting of the West Truckee Meadows Citizen Advisory Board held March 12, 2012 at the Roy Gomm Elementary School, 4000 Mayberry Drive, Reno, Nevada.

- 1.* CALL TO ORDER Chairperson Giddings called the meeting to order at 6:32 p.m.
- 2.* ROLL CALL/DETERMINATION OF QUORUM Roll call was heard and a quorum of was determined. At 6:47 p.m., Suzie Klass arrived forming a quorum of five members present.

- 7. * **NEW BUSINESS** (The Staff contact listed on items for Community Development may not be in attendance but can be contacted for code and policy questions.)
 - A.* Caughlin Fire Update Lynda Nelson, Fire Restoration Manager from the Nevada Land Conservancy, will provide an update on the recovery process on the Caughlin Fire. A question and answer period will follow. This item is informational only; no action will be taken.
 - Lynda Nelson introduced herself. She stated the Nevada Land Conservancy was the primary agency completing restoration on the Caughlin Fire and the Washoe Drive Fire. On January 9, 2012, a \$220,000 grant was received from the Truckee River Fund for restoration on the Caughlin Fire. Phase one was restoration of Manzanita Canyon below Horseman's Park. Phase two would complete \$44,000 worth of restoration in the canyon. Last week, 144 volunteers dropped 450 lbs. of seed in the upper portion of the canyon and 200 plants were planted along the Manzanita Creek drainage area. On February 25-26, 2012, seed was given away to Caughlin Fire victims. This Saturday, there will be a Washoe Fire seed giveaway from 8:30 a.m. to 11:00 a.m. at the Dry Creek Garden Nursery. The seed was donated by the Nevada Division of Forestry. There was an additional funding request for the Washoe Fire for \$150,000, which will be reviewed by the TMWA Board on March 21, 2012. Approximately \$20,000 was received from NV Energy Foundation for restoration work at Bartley Ranch and approximately \$75,000 was received from NV Energy for restoration work for both the Caughlin and Washoe Fires. The most recent donation was approximately \$10,000 from

Wells Fargo. Ms. Nelson stated most work being completed is emergency. Jersey barriers were also placed along Lakeside Drive.

Concerns/Comments

- Board member Georgeson asked exactly where on Manzanita Canyon the fire started. Ms. Nelson stated it started on the top of Pine Haven from the power lines.
- Board member Brussard asked if seeding and hydra mulching were happening at the same time and is it above or below McCarran Boulevard. Ms. Nelson stated everything being completed in Manzanita Canyon is below McCarran Boulevard.
- Board member Ryan asked what percentage of the area has been accomplished. Ms. Nelson explained that
 percentages were low in terms of acreage because large acres that were burned are on private property, but
 they were targeting the priority areas. Ms. Nelson provided a review of the 2,600 acres that burned in the
 Washoe Drive Fire.
- Board member Brussard asked who residents need to contact to allow goat herding to clear the cheat grass.
 Ms. Nelson stated residents could contact her regarding this issue.
- Board member Ryan requested to know who to contact regarding cottonwood trees being chewed by beavers. Ms. Nelson stated Eric Crump at Washoe County Parks could be contacted at 823-6518 to address the issue.
