

SUMMARY: An ordinance amending Washoe County Code Chapter 45 by removing Washoe County as the child care licensing authority and identifying the State of Nevada Division of Welfare and Supportive Services as the licensing authority.

ORDINANCE NO. 1730

TITLE: AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 45 BY REMOVING THE DESIGNATION OF WASHOE COUNTY AS THE CHILD CARE LICENSING AUTHORITY UNDER WASHOE COUNTY CODE 45.095, MODIFYING WASHOE COUNTY CODE 45.096 TO IDENTIFY THE STATE OF NEVADA DIVISION OF WELFARE AND SUPPORTIVE SERVICES AS THE LICENSING ENTITY, AND REPEALING WASHOE COUNTY CODES 45.100, 45.105, 45.300, 45.305, 45.308, 45.325, 45.331, and 45.366.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

**SECTION 1.** Washoe County Code Sections 45.095, 45.100, 45.105, 45.300, 45.305, 45.308, 45.325, 45.331, and 45.366 are hereby repealed.

**SECTION 2.** The Washoe County Code is hereby amended at Section 45.096 to amend the licensing requirements for a child care in Washoe County as follows:

**45.096 License for child care**

1. Any person desiring to provide child care in Washoe County must first obtain a license from the State of Nevada Division of Welfare and Supportive Services as outlined in NRS 432A.024.




