SECTION 1. Washoe County Code Sections 45.095, 45.100, 45.105, 45.300, 45.305, 45.308, 45.325, 45.331, and 45.366 are hereby repealed.

SECTION 2. The Washoe County Code is hereby amended at Section 45.096 to amend the licensing requirements for a child care in Washoe County as follows:

45.096 License for child care

1. Any person desiring to provide child care in Washoe County must first obtain a license from the State of Nevada Division of Welfare and Supportive Services as outlined in NRS 432A.024.
