

This is a request to approve an abandonment of Washoe County's interest in two 33-foot-wide government patent access along the west and south property lines of APN: 142-241-03.







Evaluation




- The applicant is requesting to abandon the west and south 33-foot-wide access easements for a parcel.
- This parcel was created by the US government and 33-foot-wide easements were established on all sides of the parcels of land. to allow roads to be located where access was needed.
- White's Creek Lane is located within the northern easement and provides access to the parcels to the west and east.
- Bihler Road, located within the eastern easement provide access to parcels to the east and south.
- The remaining two easements- west & south- are not being used for access and the applicant is requesting to abandon these two easements.


