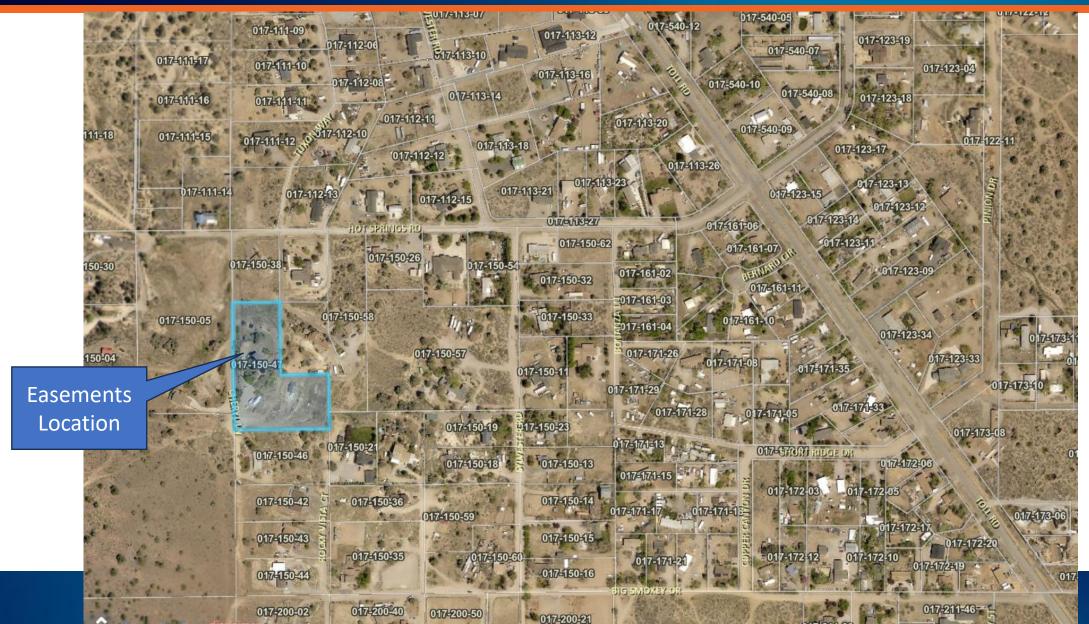


This is a request to approve an abandonment of Washoe County's interest interests in the following:

- 1. A 33-foot-wide easement on the western property line of the parcel;
- 2. A 33-foot-wide easement on part of the eastern property line of the parcel; and
- 3. A 66-foot-wide easement in the southern portion of the parcel.

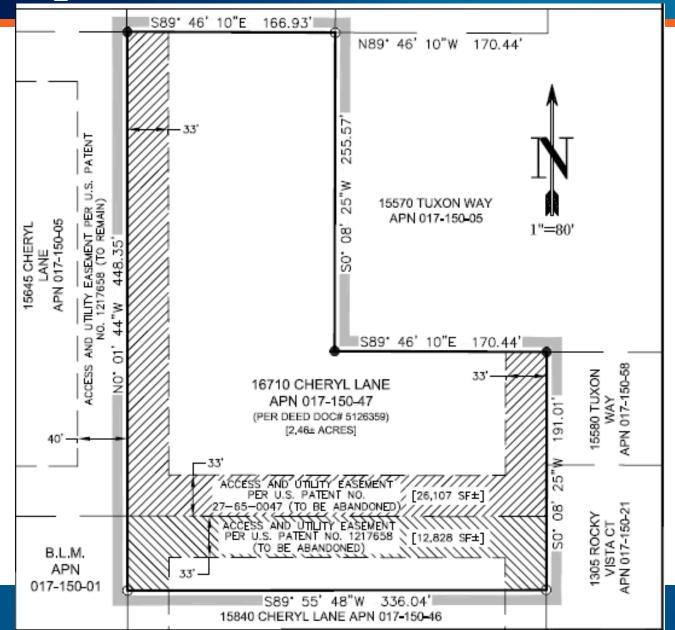
Vicinity Map





Easement Map

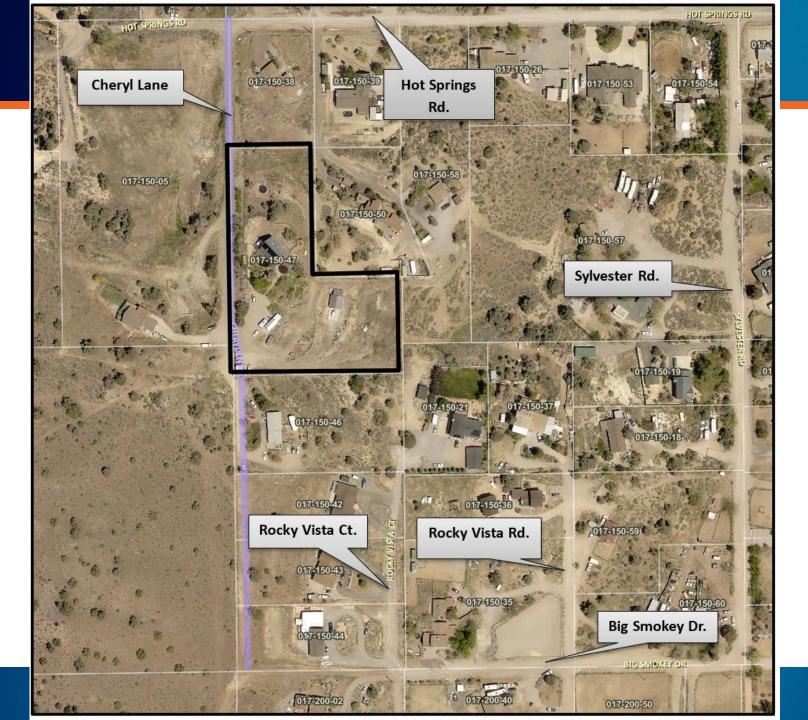




Evaluation



- The request is to abandon Washoe County's interest of three easements.
- Two easements do not provide access to any of the surrounding parcels, the 33-foot-wide easement along the subject parcel's eastern property line and the 66-foot-wide easement within the southern portion of the parcel.
- The surrounding parcels have established access from other access easements, including those providing access via Rocky Vista Road, Rocky Vista Court, Big Smokey Drive, Sylvester Road, and Hot Springs Road.





Evaluation

- The 33-foot-wide Cherly Lane easement does provide access to the parcel adjacent to the south of the applicant parcels.
- The adjacent parcel to the west has 40-foot easement for Cherly Ln.- totaling a 73-feet wide easement.
- The dirt roadway for Cheryl Lane is located completely on the adjacent parcel.
- The current dirt road does jog to the west onto a federal government owned parcel and there is no access easement on the federally owned parcel for Cheryl Lane.







Recommendation



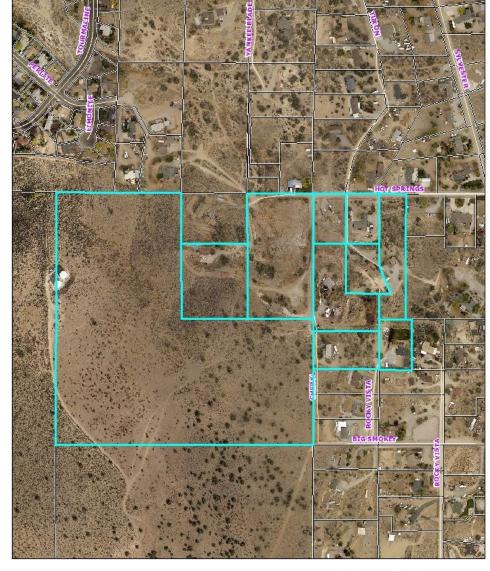
- Staff is recommending partial approval of this abandonment request:
 - 1. Abandoning the 33-foot-wide easement along the subject parcel's eastern property line and the 66-foot-wide easement within the southern portion of the parcel; and
 - 2. Abandoning 13-foot-wide easement on the west side of the applicant's parcel, to preserve a 20-foot-wide portion of the Cheryl Lane easement on the applicant's parcel.
