SUMMARY

FUNDING REQUEST FOR SPARKS POLICE DISPATCH PSAP for REPLACEMENT OF COMMONLY FAILING RADIO COMPONENTS [For possible action] – A review, discussion, and possible action to approve, deny or otherwise modify a request to fund the costs associated with replacement of commonly failing radio components for L3Harris Symphony Radio Consoles, in an amount not to exceed \$20,000.

NRS APPLICABLE:

NRS 244A.7645 provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is the primary Public Safety Answering Points (PSAPs) for Sparks Police Department.

PREVIOUS ACTION & BACKGROUND

The E911 Emergency Response Advisory Committee has previously approved the request to fund the purchase of Symphony radio consoles for all three (3) primary PSAPS as well as their components.

On January 16, 2020, and again on January 21, 2021, the E911 Emergency Response Advisory Committee approved the request to reimburse the costs associated with the purchase and installation of four (4) Harris Symphony Radio Workstations for Sparks Police Department PSAP.

All PSAPs have been experiencing increased failures. Today's request is for funding the costs associated with the replacement of commonly failing radio components for SPARKS PSAP to mitigate these issues on our current ten (10) radio consoles, in an amount not to exceed \$20,000.

Breakdown of costs as of 12/2/24:

Ten (10) FootSwitch/Foot Pedals & Ten (10) Audio Jacks	\$ 5,510.12
Ten (10) Solid-State Drives (SSDs)	\$13,364.35
Total Estimated Cost	\$18,874.47

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to reimburse Sparks PSAP for the costs associated with the replacement of commonly failing radio components for L3Harris Symphony Radio Consoles, in an amount not to exceed \$20,000.
