SUMMARY

REQUEST FOR REIMBURSEMENT FOR SPARKS POLICE DISPATCH PSAP for PURVIS FIRE STATION ALERTING [For possible action] – A review, discussion, and possible action to approve, deny or otherwise modify a request to reimburse the costs associated with Dispatch-Fire Station Alerting System software, hardware, and installation for Sparks Emergency PSAP for an amount not to exceed \$33,898.

NRS APPLICABLE:

NRS 244A.7645 authorizes the utilization of 911 surcharge funds to enhance the telephone system for reporting an emergency and for purchasing and maintaining portable event recording devices.

STAKEHOLDER REVIEW(s)

Stakeholder is the primary Public Safety Answering Points (PSAPs) for Sparks Police Department.

PREVIOUS ACTION & BACKGROUND

On October 28, 2021, the E911 committee approved a 5-year Master Plan that included planned funding of fire station alerting systems for Reno, Sparks, and Truckee Meadows Fire Protection District during FY 21/22.

The Reno Fire Department and Truckee Meadows Fire Protection District requested funding for the same fire station alerting system, software, and equipment on September 23, 2021, and November 18, 2021. Both systems were approved for the amounts requested, which was approved for an amount not to exceed \$1,240,000 and \$1,030,000.

On February 10, 2022, the E911 committee approved the request for funding for the Dispatch-Fire Station Alerting System software, hardware and installation costs for the City of Sparks Fire Department in an amount not to exceed \$560,000 to allow the City of Sparks Fire Department to move forward with the purchase and implementation of said system.

Sparks PSAP currently only has two (2) Dispatch PURVIS monitors at opposite ends of the dispatch center. Sparks PSAP discovered that this is inadequate for their dispatching needs. Sparks PSAP needs a PURVIS monitor at every Fire Dispatching Station for the best citizen response and to avoid delays in toning, alerting, and dispatching fire when dispatch must perform a by-pass or re-page.

Today's request is for \$33,898 to reimburse Sparks Police Department PSAP for the licenses, wiring, installation, hardware and software for eight (8) additional PURVIS Fire Alerting System Dispatch Consoles and one (1) remote Dispatch Console that are needed for the PSAP to operate the most efficiently for citizens calling in a Fire or Medical emergency.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to reimburse Sparks PSAP for the costs associated with Dispatch-Fire Station Alerting System software, hardware, and installation for Sparks Emergency PSAP for an amount not to exceed \$33,898.
