PREVIOUS ACTION BACKGROUND

In the E911 Emergency Response Advisory board meeting July 18, 2024, the Board approved funding to reimburse the County for the standard English version of IAED Platinum Package.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system. Budget authority exists within the E911 Fund to the travel and training to the public safety training conferences for registrations, seminars and meetings.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund/reimburse all costs associated with implementing International Academy of Emergency Dispatching (IAED) ProQA call taking on-line software additional language USS (United States Spanish) in EMD for a total cost not to exceed \$6,600.00 as well as EFD for a total cost not to exceed \$6,600.00 for a one-time grand total not to exceed \$13,200.00.
