### **SUMMARY**

**REQUEST FOR EQUIPMENT REIMBURSEMENT FOR CITY OF RENO PUBLIC SAFETY DISPATCH PRIMARY PSAP (Public Safety Answering Point)** [For Possible Action] - A review, discussion and possible action to approve, deny or otherwise modify a request to reimburse the costs associated with purchasing three (3) Harris VIP Dispatch workstation licenses and required operational accessories in an amount not to exceed \$25,204.75.

**NRS APPLICABLE:** *NRS 244A.7645* Provides approval of costs associated with purchasing, leasing or renting the equipment and software necessary to operate the enhanced telephone system, including, without limitation, equipment and software that identify the number from which a call is made, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

### **STAKEHOLDER REVIEW(s)**

Stakeholder is a primary Public Safety Answering Points (PSAP) – City of Reno Public Safety Dispatch.

### **PREVIOUS ACTION&BACKGROUND**

On May 21, 2025, Washoe County Sheriff's Office Communications received approval to fund the purchase of 7 Harris VIP Dispatch Consoles.

On May 21, 2025, Sparks Police Dispatch received approval to fund the purchase of four (4) Harris VIP Dispatch Consoles.

### **FISCAL IMPACT**

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

### **RECOMMENDATION**

It is recommended that the E911 Emergency Response Advisory Committee approve the request to reimburse the costs associated with purchasing three (3) Harris VIP Dispatch workstation licenses and required operational accessories in an amount not to exceed \$25,204.75; and if approved forward such recommendation to the Board of County Commissioners.
