## **SUMMARY**

Public Safety Equipment for the Washoe County Sheriff's Office Communications PSAP:

The Communications Center requests reimbursement for the acquisition of two (2) 2 Dell Pro Max Tower T2 FCT2250 computers and four (4) Dell Pro 34 Plus monitors-P3424WEB which will be utilized by the Dispatch operators working in the Real Time Intelligence Center. These stations are required to support NG-911 call handling, computer-aided dispatch (CAD), RapidSOS integration, and enhanced situational awareness tools such as Drone as a First Responder, Real time intelligence, and live view camera and body camera information, all housed within the Northern Nevada Regional Intelligence Center. The housing of Emergency dispatch operators within the Northern Nevada Regional intelligence Center will allow them access to additional resources such as license plate reader technology, drone as a first responder live video feeds, live view Axon Body camera feeds, and information from on-site crime analysts which will enhance first responder safety and communication abilities.

### NRS APPLICABLE

NRS 244A.7645 authorizes funding for the acquisition, maintenance, replacement, and upgrade of equipment and software necessary to operate the enhanced 911 telephone system, including hardware that directly supports PSAP operations.

#### PREVIOUS ACTION & BACKGROUND

The E911 Emergency Response Advisory Board has previously approved reimbursement for training and technology upgrades (e.g., RapidSOS, IAED). This request continues those enhancements by modernizing PSAP operator stations, ensuring compliance with NG-911 standards and continuity of operations.

## FISCAL IMPACT

The Enhanced 911 Fund is a special revenue which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system. Budget authority exists within the Fund to acquire and replace PSAP equipment, ensuring dispatchers have the tools necessary for public safety operations.

Dell Invoice No. 10842380068 (dated October 19, 2025), and Dell Invoice No. 10842036771 (dated October 16, 2025), provides the following items:

- Dell Pro Max Tower T2 FCT2250 computers 2 units @ \$2,335.77 each = \$4,671.54
- Dell Pro 34 Video Conferencing Monitor P3424WEB- 4 units @ \$565.00 each = \$2,260.00
- TOTAL = \$6,931.54

## **RECOMMENDATION**

It is recommended that the E911 Emergency Response Advisory Committee approve the request reimburse all costs associated with the purchase of Tactical E911 Operator Stations (computers, and monitors) for the Washoe County Sheriff's Office Communications Center, in an amount not to exceed \$6.931.54

Move to approve the reimbursement request for the Washoe County Sheriff's Office Communications Center to acquire 2 computers and four monitors, supporting NG-911 and dispatch operations, in an amount not to exceed \$6,931.54
