SUBJECT: REQUEST FOR FUNDING FOR THE HEXAGON ONCALL DISPATCH (CAD) INTEGRATION WITH VERINT (911 AUDIO RECORDING SOFTWARE): [For Possible Action] - A review, discussion and possible action to approve, deny or otherwise modify a request to fund the costs associated with developing and implementing the required software interface between Verint (911 audio recording software) and Hexagon OnCall Dispatch (CAD) for a total amount not to exceed \$26,450; and if approved forward such recommendation to the Board of County Commissioners.

SUMMARY

A review, discussion and possible action to approve, deny or otherwise modify a request to fund the costs associated with developing and implementing the required software interface between Verint (911 audio recording software) and Hexagon OnCall Dispatch (CAD) for a total amount not to exceed \$26,450

Nevada Revised Statutes (NRS) 244A.7645 3.A.3 authorizes the use of E911 surcharge funds for “Purchasing, leasing or renting the equipment and software necessary to operate the enhanced telephone system, including, without limitation, equipment and software that identify the number or location from which a call is made;” and “Paying costs associated with any maintenance, upgrade and replacement of equipment and software necessary for the operation of the enhanced telephone system.”

The local Public Safety Answering Points (PSAPs) connect to and utilize Verint audio recording software solution to record and maintain all 911 audio recordings. The Verint recording solution is currently provided to the local PSAPs and managed through the Great Migration contract with Intrado Safety Solutions. The integration between these two systems would allow 911 recordings to be accurately labeled and retained through an automated transfer of metadata generated through the CAD system. This new feature will enhance the operations of the 911 system and ensure that accurate records and data related to 911 phone calls are retained according to Nevada State Law.

The referenced interface in the attached quote will provide service for the City of Reno Public Safety Dispatch, City of Sparks Police Department Dispatch, and Washoe County Sheriff’s Office Communications, including all user agencies supported by the referenced PSAPs and Truckee Meadows Fire protection District.

NRS APPLICABLE: *NRS 244A.7645* Provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholders are primary Public Safety Answering Points (PSAPs) & User Agencies of those PSAPs – City of Reno Public Safety Dispatch, City of Sparks Police Department Dispatch, and Washoe County Sheriff’s Office Communications, Reno Police Department, Reno Fire Department, Sparks Police Department, Sparks Fire Department, Truckee Meadows Fire Protection District.

PREVIOUS ACTION&BACKGROUND

April 17, 2025- Washoe County obtained approval of the interface between Purvis Fire Station Alerting System software and Hexagon OnCall Dispatch in an amount not to exceed \$58,500.

January 03,2020 – Washoe County obtained approval to approve the Change Order for Services between Washoe County and Intrado Inc. for the upgrade of the current Verint Recording Solution in an amount not to exceed \$633,600.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund the costs associated with developing and implementing the required software interface between Verint (911 audio recording software) and Hexagon OnCall Dispatch (CAD) for a total amount not to exceed \$26,450; and if approved forward such recommendation to the Board of County Commissioners.

Hi Cody,

This is what i've used in the past, and the fields are the ones that got the go ahead on a previous email.

The Verint API will be used to extract 21 fields from the Hexagon system and insert this data into the Verint system to be used to query calla based on this data. All data required must be available to/through Verint API / Interface. Motorola/Verint will not provide any calculations or calculated fields

ConsolePosition (this is the terminal that took the 9-1-1 call....I think more what you are looking for rather than CreatedTerminal)

ServiceClass

The Verint Recording Servers also include the capability to capture and tag E911 ANI/ALI information to the call database record. This will enable operations center staff to perform search and retrieval using ANI & ALI information.

- **Important Note:** We will need to verify the Make/Model of the ANI/ALI controller and the availability of a useable ANI/ALI "CADSPILL" or Post Call CDR or Enhanced CDR. Testing may be required to verify usability of the data source.

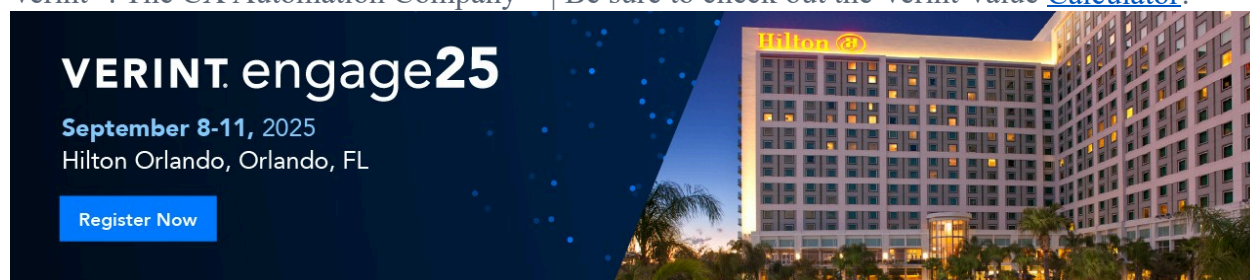
