STAKEHOLDER REVIEW:

Stakeholders are the area Primary Public Safety Answer Points (PSAP)- City of Reno Public Safety Dispatch, City of Sparks Emergency Communications, and Washoe County Sherriff's Office Communications.

PREVIOUS ACTION & BACKGROUND:

On September 18th, 2025, the 9-1-1 Emergency Response Advisory Committee approved reimbursement for the Sparks Police Dispatch PSAP for the costs associated with purchasing eleven (11) Dell UltraSharp 27” Monitors and sixty-two (62) Dell UltraSharp 24” monitors and ten (10) CAD PC’s, in an amount not to exceed \$39,509.19.

FISCAL IMPACT:

The Enhanced 9-1-1 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

It is recommended that the Washoe County Emergency Response Advisory Committee approve the request to reimburse the costs associated with purchasing Dell Monitors, \$429.00 each; quantity twenty-four (24), not to exceed \$10,296.00.
